

## **HUSSMANN CORPORATION WARRANTY**

2-Year Self-Contained Warranty with 5-year Compressor Coverage

#### Models covered:

BCH, DDSSC, GSVM, HGM, ISFGG, ISMGG, HGL, LBN, LTH, NAV, NAVC, SHM, SIM, SM, and SN

Hussmann warranties to the original purchaser the new equipment and all original parts to be free from defects in material and workmanship under normal use and service for a period of 24 months from date of PROPER INSTALLATION AND START-UP\*\*, with the end warranty coverage not to exceed the maximum of 27 months from date of shipment from factory.

A new part (excluding compressors) will be provided without charge during the applicable warranty time, provided the defective part is returned to Hussmann and deemed a true warranty failure. The **replacement part assumes the unused portion of the warranty remaining**. Any parts determined not to be warrantiable or not returned, **WILL BE CHARGED TO THE ACCOUNT ON FILE AT THE TIME THE PART ORDER WAS PLACED**.\*

## **Self-Contained Warranty Labor Coverage:**

Labor coverage shall not exceed 24 months from date of PROPER INSTALLATION AND START UP—with the end warranty coverage not to exceed the maximum of 27 months from date of shipment from factory.

IMPORTANT TO NOTE—WARRANTY DOES NOT COVER CLAIMS CAUSED BY IMPROPER INSTALLATION AND LACK OF BASIC PREVENTATIVE MAINTENANCE.

Any warranty claim filed, must be submitted to Hussmann within 45 days of the warranty repair date, along with the required current warranty documentation. Hussmann reserves the right to request installation, startup and preventative maintenance documents for claims review and processing and may reject any claim where the customer cannot prove installation, start-up, and maintenance were performed pursuant to the corresponding Equipment Manual.

#### **NEW EQUIPMENT PARTS INCORRECT/MISSING**

Any parts incorrect/missing must be reported to Hussmann no more than 30 days from delivery to site, not to exceed 60 days from shipment from factory. After this time has expired, Hussmann will assume the parts are correct or were lost during the installation, and parts will be charged plus shipping to replace.\*

# **PATENT WARRANTY**

Hussmann warrants that its products do not infringe the claims of any existing United States patent, but Hussmann makes no warranty against infringement by reason of the use thereof either in combination with other products or in the operation of any process or use of the products other than for their intended purpose. This warranty is subject to purchaser promptly notifying Hussmann in the event of any action for such infringement brought against purchaser and permitting Hussmann to participate in the defense of such action. Hussmann reserves the right to modify or replace any product alleged to constitute and infringement, or to remove such product and refund the amount paid by purchaser therefore. This warranty is not transferable. The foregoing patent warranty shall not apply to any product or part thereof made to purchaser's design, and as such product or part. Hussmann assumes no liability for patent infringement. The foregoing states the entire liability of Hussmann with regard to patent infringement.

Any warranty repair made by Hussmann or other providers shall not extend the term of the warranty.

## **Warranty Exclusions:**

# THIS WARRANTY SHALL NOT APPLY TO LOSS OF FOOD OR CONTENTS OF THE PRODUCTS DUE TO FAILURE FOR ANY REASON. HUSSMANN SHALL NOT BE LIABLE:

- For payment of labor for any removal or installation of warrantied parts, unless specifically called out on the Warranty Schedule posted on the Hussmann Website; In effect at the date of shipment of the product.
- · For travel to and from store locations and work sites—this includes truck charges, fuel surcharges, and driver fees.
- For administrative fees for preparing claims or entering them into Hussmann claim system.
- For Mark-ups on items used to repair cases.
- · For any repair or replacements made without the written consent of Hussmann, or when the product is installed or operated in a manner contrary to the printed instructions covering installation and service, which accompanied such product.
- · For any damages, delays, or losses, direct, consequential, incidental or otherwise, which may arise in connection with such product or part thereof; including loss of profit, additional labor cost, or injury to personnel or property caused by defective material or parts.
- · For damages or delays during shipment or caused by fire, flood, strikes, or other circumstances beyond its control.
- · For delayed freight shipments caused by carriers or customer scheduling conflicts with provider, which incur costs.
- · When the product is subject to negligence, abuse, misuse or when the serial number of the product has been removed, defaced, or altered.
- · When the product is operated on low or improper voltages.
- When the product is put to a use other than as recommended by Hussmann.
- When operation of the product is impaired due to improper drain installation.
- · For payment of refrigerant loss for any reason.
- · For costs related to expedited shipping or handling of replacement parts.
- For periodic maintenance items such as filters, gaskets, lamps, fuses, driers, etc.
- · For diagnostic charges.
- · To defend, indemnify or hold harmless any purchaser or end-user for any claims, demands, lawsuits or actions of any nature.
- · For overtime, double-time, or holiday charges regarding labor.
- · For tools/items used for repair (such as but not limited to: vacuum, nitrogen, reclaim, etc.).
